## **Personal Data Protection Policies**

### **CONSENT TO THE PROCESSING OF PERSONAL DATA**

I grant my consent in accordance with Article 6(1)(a) and Article 7 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (hereinafter referred to as "GDPR").

4. I acknowledge that the performance of the contractual relationship between me and the Administrator is not conditional upon the granting of this consent.

8. I am aware that I am entitled to certain rights arising from the granting of this consent, including:

The right of access to personal data, the right to rectification or completion, the right to erasure, the right to restriction of processing, the right to data portability, the right to object.

9. I am aware that the right to erasure (to be forgotten) constitutes an obligation for the Administrator to destroy personal data if at least one of the following conditions is met:

- the personal data is no longer necessary for the purposes for which it was collected or otherwise processed,
- the data subject withdraws consent and there is no further legal basis for the processing,

- the data subject objects to the processing and there are no prevailing legitimate grounds for the processing,
- personal data has been processed unlawfully,
- personal data must be deleted to comply with a legal obligation,
- personal data has been collected in connection with the offer of information society services pursuant to Article 8(1) of the GDPR.

10. I am aware that personal data is not subject to automated decision-making.

11. I am aware that personal data will not be transferred outside the EU.

12. I am aware that personal data will be processed on the basis of this consent for as long as necessary, but no longer than 10 years.
